- 2023-2024 Romania's Ministry of Agriculture continues to grant temporary authorizations for treating seeds with neonicotinoids.
- 2025 The derogations granted in 2024 for the treatment of sunflower and corn seeds for the period January-May 2025 have been suspended by the courts following a lawsuit filed against the Ministry of Agriculture by ROMAPIS, the Federation of Beekeepers' Associations of Romania, and Ecoruralis, the alliance of small Romanian farmers.

Large farms (many of them exceeding 10,000 ha), which represent less than 0.5% of all farms, are the ones putting pressure on the Ministry of Agriculture to obtain derogations.

Over the past 11 years, the Ministry of Agriculture has granted a total of 55 derogations for the use of neonicotinoids. The voice of the vast majority of 99.5% of Romanian farmers, including beekeepers, has never mattered, while the requests of 0.5% of wealthy and powerful farmers have always been taken into account.

The EU-wide survey conducted by IPSOS in 2023 shows that Romanians, among all Europeans, are:

- the most concerned about the impact of pesticides on their families' health (84.1%)
- the most concerned about food safety (87.1%)
- the least confident in government decisions on pesticide use in relation to public health and the environment (51%).

The survey conducted in Romania by CURS in 2025 shows that Romanians:

- do not want food products that come from crops treated with pesticides (89%)
- do not believe that farmers in Romania should use pesticides that are banned in the European Union, such as neonicotinoids (89%).
